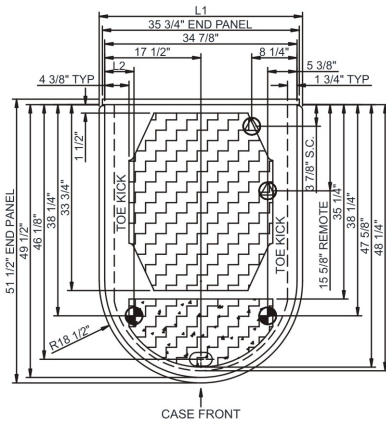

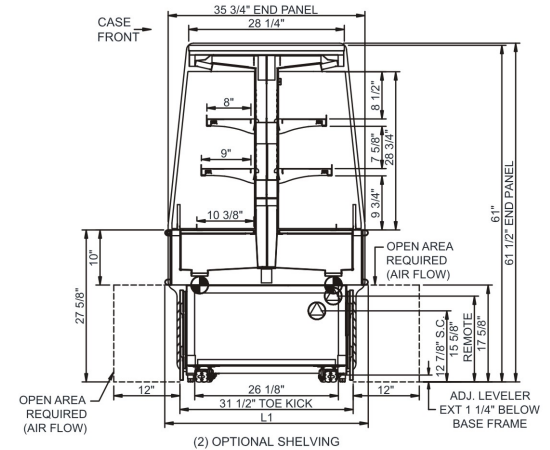
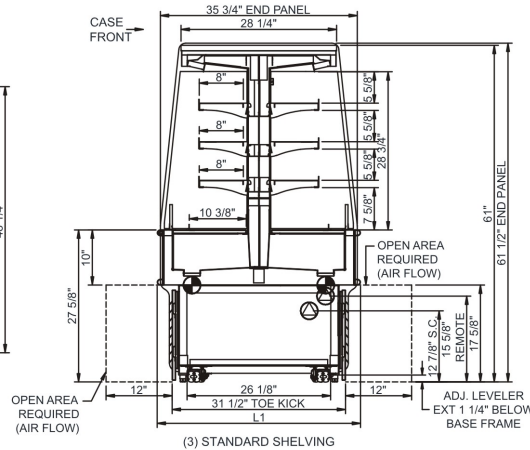

Important Notes:

- 1) ELECTRICAL NOTE: If GFCI is required, a GFCI breaker MUST be used in lieu of a GFCI receptacle
- 2) 37" minimum door entry clearance required (without shipping skid).
- 3) Units are supplied with levelers. They must be adjusted during installation to ensure the unit is level and plumb. Dimensions reflect levelers extended 1 1/4".
- 4) Performance issues (product temperatures, water on floor, etc.) caused by adverse conditions are not covered by warranty.
- 5) Keep unit at least 15' from exterior doors, overhead HVAC vents, or any air curtain disruption.
- 6) End panels must be tightly joined or kept at least 6" away from any structure to prevent condensation.
- 7) Do not expose unit to direct sunlight or any heat source (ovens, fryers, etc.).
- 8) Compressor air intake in one side & out other side. All louvered panels cannot be blocked.
