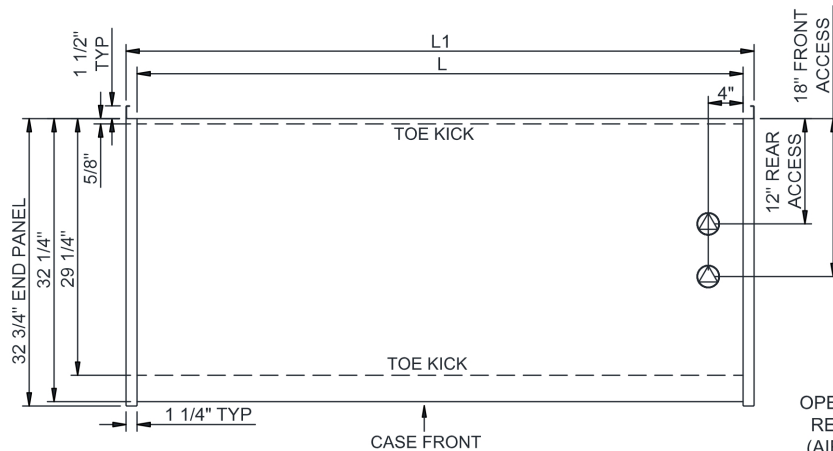

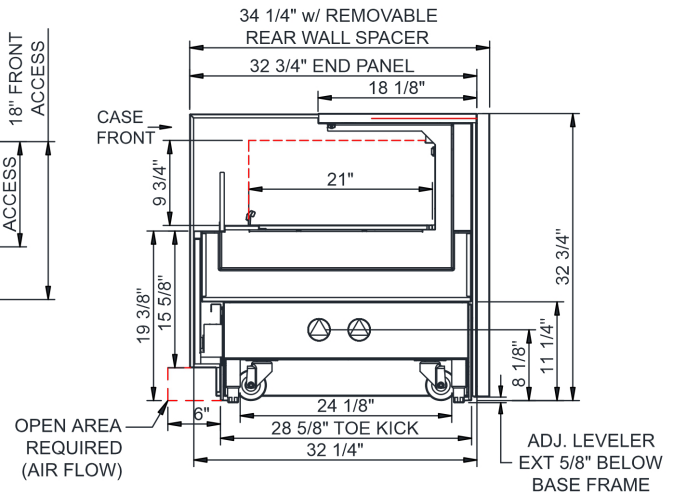

Important Notes:

- Keep unit at least 15' from exterior doors, overhead HVAC vents, or any air curtain disruption.

- Front access compressor air intake at lower front, discharge from lower rear. Lower panels cannot be blocked. Wall spacers required for proper air flow. Rear access reverses air flow direction.
- If GFCI is required, a GFCI breaker MUST be used in lieu of a GFCI receptacle.
